The following is a snapshot of governance work history from recent roles.

Transport & Automotive

Gordon has a strong skill set across Transport & Automotive.

Gordon has worked at Director and CEO level in the vehicle inspection, regulatory, policy and used retail areas both in NZ and Japan.

Gordon has been in leadership roles for transport sector organisations navigating regulatory change, COI management and mitigation, people and organisational change, IPO's and process improvement initiatives.

From Aug 2022 until Jan 2023 Gordon was Interim CEO for NZ Automotive Investments the parent company for 2 Cheap Cars. From Feb 2023 Gordon is now an Independent Director for the 2 Cheap Cars Group.

From 2014 to 2022, Gordon was CEO, and then Executive Director of Vehicle Inspection NZ Ltd a nationwide provider of regulatory vehicle inspections. VINZ is part of a global group of companies who provide inspection services and various services across the automotive supply chain.

Part of his group accountabilities was to lead the development of new products and services in Australia, Fiji and Japan.

Gordon also held senior roles within JEVIC Japan, and Optimus Group Japan a Tokyo Stock Exchange [TSE] listed entity.

In the early 2000's Gordon held an operational role at LTSA [now Waka Kotahi] in a role accountable for the management and delivery of LTSA's service delivery strategy.

Listed entity executive management and governance

During Gordon's current tenure with 2 Cheap Cars Group Ltd Gordon has had experience with NZX listing rules and regulations including the holding and Chairing of an ASM for NZAI, preparing and releasing market updates and appointments of directors. Gordon also has experience in working with the NZX and RegCo on various market matters.

CEO reporting to a Board

During Gordon's time as Interim CEO of NZ Automotive Investments and Vehicle Inspection NZ CEO Gordon reported to the Boards of both entities.

Gordon worked with the Chair(s) on board reporting, strategy, and governance approach and in the setting of meeting agendas and a streamlining of reporting to the board.

Gordon also attended the board meetings of VINZ Group parent company (Optimus Group Japan) as Chief Secretary of the Conflict of Interest Council.

Conflict of Interest Governance

In Gordon's role as the inaugural Chief Secretary of the Optimus Group's Conflict of Interest Council, he was involved in the establishment [January 2019] of the council for the COI management across the multinational group of Optimus.

The Optimus Group is a Tokyo Stock Exchange (TSE) listed entry based in Japan. The Optimus COI Council is a Board mandated subcommittee reporting direct to the board on COI matters for the group.

Main role of The COI Council was to assess the following group company matters and report to the Board of Directors:

- Governance environment, maintenance, and operational status of regulations
- Concerning conflicts of Interest
- Identification and effective management of risk of conflict of interest
- Appropriate monitoring and maintenance of appropriate reporting systems
- Other matters deemed necessary by the Board of Directors

Gordon's role included:

- 1. Meeting management of Council and Chairing the monthly meetings
- 2. Monthly reporting to Optimus Board [written and verbal]
- 3. J-SOX reporting
- 4. COI training for NZ based senior leaders

Health & Safety

Gordon was a steering group member of the <u>Business Leaders H&S Forum</u> from Nov 2018 to June 2023. The forum has a recent focus on mental health and wellbeing of company executives, and has been active in recent discussions of the forums positioning in this area.

In Gordon's former role at Vehicle Inspection NZ, he had H&S governance responsibilities within the VINZ Board. This included a review of our H&S procedures and the protection of customers on sites.

In his role as CEO at VINZ I led the VINZ operationalisation of the new H&S legislation, the creation of the VINZ H&S Campions scheme and have moved VINZ to a future looking organisation with its approached of H&S issues such as wellbeing, fatigue, mental health, and hearing

Gordon has completed H&S training with the IoD and Business Leaders Health & Safety forum.

Sustainability and ESG

As a member of the IoD and a current director in NZ Gordon has been exposed to the mechanics of Environmental, Social and Governance (ESG) sustainability reporting and the need for Boards to enable and give focus to integrated sustainability reporting.

In his current roles he has had various board tasks that require him to work with executive teams to set up targeted metrics and reporting is an important tool in improving the understanding of the relationship between financial and non-financial factors that determine a company's performance.

In the early 2000's Gordon consulted in the carbon neutral reporting space providing inventories and mitigations actions for organisations such as the NZSO and presented 2-day public seminars via CONFERENZ.

Community engagement, corporate diversity and te reo and tikanga

Gordon was [Nov 2021] selected by <u>The Superdiversity Institute</u> and the Ministry for Ethnic Communities as a recipient of the 'Top Diverse Board-Ready Directors List 2021'.

Having worked for many Government Departments and agencies Gordon is well versed in obligations to the Treaty including the ability to speak basic Te Reo and was one of the first European New Zealander to make a formal greeting in Reo at Te Papa's upper Marae.

Automotive - Regulatory

Gordon is well versed in the mechanics of navigating in complex regulatory environments having worked at LTSA the forerunner for Waka Kotahi, partnering with Waka Kotahi and MPI in his roles at VINZ and JEVIC and on the transition to Auckland Council and in both Auckland Council and Auckland Transport post establishment.

In Gordon's current role with 2CC Group he has been leading the engagement with Waka Kotahi on the clean car standard.

Gordon has represented VINZ in Ministerial meetings and submissions and presentations to the Primary Production and the Transport and Infrastructure Select Committees.
